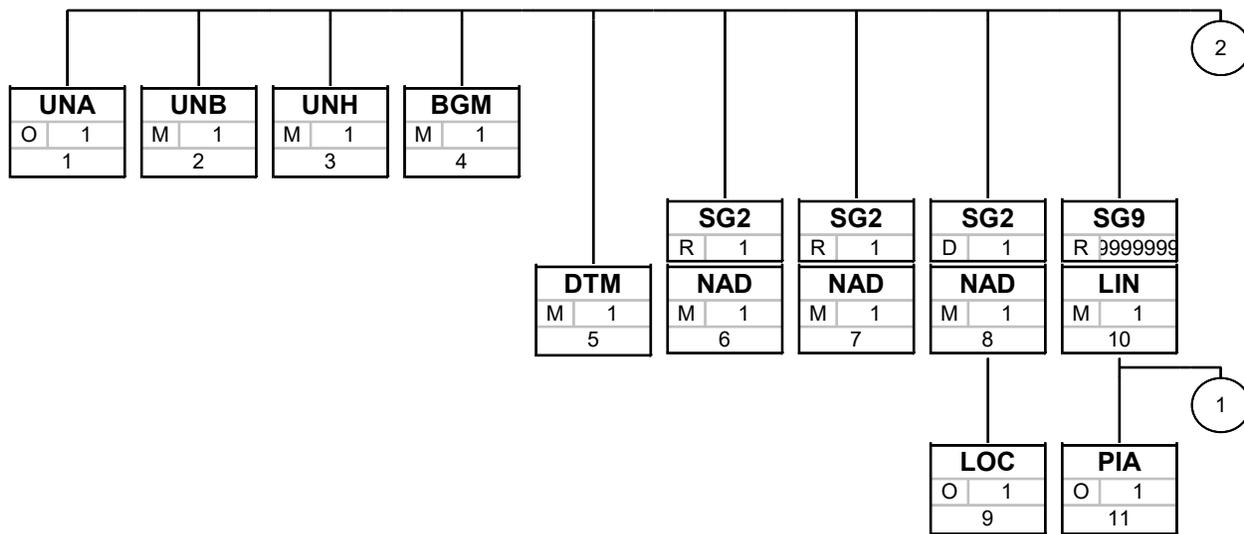

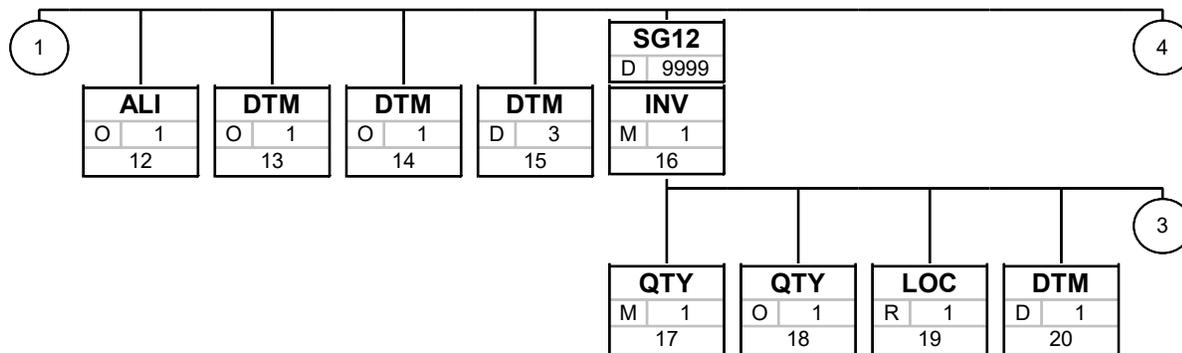

## Branching Diagram of Used Segments/Groups



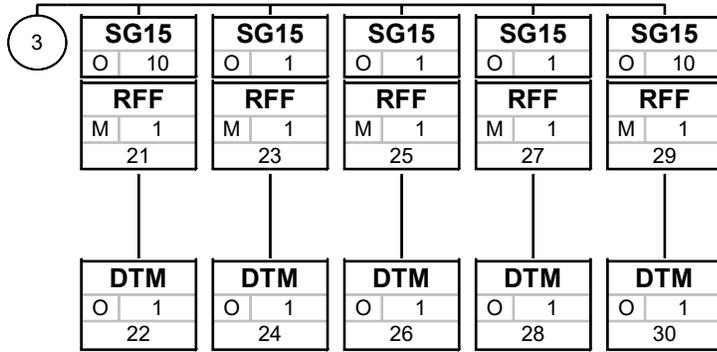

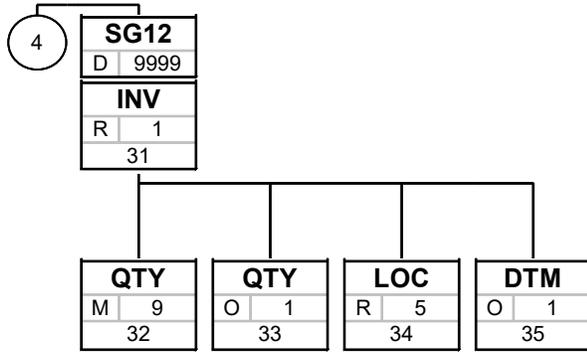

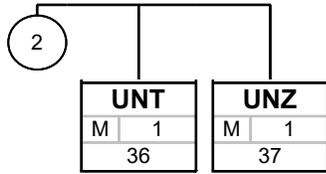
